Subse Grant of Recognition to the school from Ist to VIIIth class (without aid) w.e.f. academic session 1989-90.

Sir,

with reference to your application on the subject noted above. I am directed to grant recognition to your second from Class Ist to VIIIth (without aid) w.e.f. 1989-90 session subject to the fulfilment of the following terms & conditions:

- 1. That the school shall abide by the provisions of Delhi School Education act & Rules, 1973 french thankender as well as the instructions issued from time to thing.
- 2. That the school shall admit students without day, discrimination of caste and creed as per the norms of the department.
- 3. That the school shall appoint full time qualified and eligible staff as per the norms of the department.
- 4. That the school shall equip the science lab. 's per the norms of the department and suitable facilities for practical work shall be provided to the studies. More material worth Rs.5000/- shall be purchased during 1939-90 and a list be furnished to the Education Officer for verification.
- 5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of ten books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs.5000/- be purchased and the list be furnithed to Education Officer for verification.
- Adequate sports materials shall be purchased and made available to the students immediately.
- 7. That the school shall strictly abide by the provisions of Delhi School Education Act & Rules, 1973 and payment be made as per section 10(1) of Delhi School Education Act, 1973 to all the employees.
- 8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class-tock ert the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education Delni in each class. Number of existing sections should not exceed the number of class-room of proper size in the school.
- 9. That the school shall dispense with the services of unqualified and over-aged staff, if any, imm-distaly.

- 10. That Government nominee in the Managing Committee that he asked immediately and all decisions will be taken to mentioned in the approved Managing Committee at it approved scheme of Management by DDE(Act).
- That the scheme of management shall be got approved from the department immediately and if approved, her of members be submitted to the DDE(Act) immediately.
- 12. The Managing Committe of the school shall not increase/ enhance the fee during the ensuing Academia Session without the prior approval of the Director of Education which a manadatory requirement under sub-section (3) of Section 17 of Delhi School Education Act, 1973.
- 13. The Managing Committee shall regulate the functioning of school strictly in accordance with the provisions of Act and Rules.
- 17. That the service contract between the management and the employees shall be executed immediately.
- 15. That all the facilities prescribed under Rule 50 and 51 of the D.S.E.R., 1973 shall be made available to the students. Provisions of Rules 6, 7 and 8 be strictly observed.
- 16. That the arrangement of good drinking water shall be made available to all the students/teachers and assistary facilities shall also be provided to the arrichts immediately.
- Fresh Health Certificate may be obtained from the M.C.D. within a month and be submitted to the aturismustation Education Officer for verification.
- 18. The staff should be paid full salary through tross chaque from the date of opening of the school and the groof should be shown to the concerned Education Officer.
- 19. That the management of the school shall charte a Peserve Fund of Rs.5000/- only in a joint account in the name of Director of Education and the Manager of the school in any scheduled Bank within a month.
- 20. That the school shall not run and un-receipt if classes or any other activities within the school primises and all the recognised classes shall be run and out place at the above address only. Nursery classes be amoved from the premises of the school immediately, if any.
- 21. The Management of the school will obtain land from DM in the name of the Society through Directorate of Education Delhi and shall construct a school building thereon for the school as per specification of the department within a period of 2 years. That adequate and sufficient accommodation @ 12 sq.ft. per student shall be provided for the class room. The normal size of the class room will be 24' x 20'. No other activities other than education shall be run.
- 22. That the Nursery classes will not run in the building occupied by the school.
- 23. Medical facilities, leave, L.T.C., Bonus, teaching allowances, C.P.F. etc. be paid since recognition of school.

- 24. That the violation of any instructions/orders/conditions/ rules and regulation of the department shall lead to the wit crawal of recognition of the school and class-IX shall not be opened without the prior approval of the Director
- 25. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six months.
